PUBLIC HEARING

Discuss Road Closures for First Friday Event-Perkasie Towne Improvement Association

Upon motion by Purcell, seconded by Clark, Council unanimously approved the road closure of North 7th Street from Market Street to Arch Street, and Market Street from North 7th Street to South 6th Street on Friday, December 3rd from 4:00PM to 8:00PM.

Multi-Modal Transportation Fund Grant-Update

Council was updated on the revised concept plan for the Multi-Modal Grant at 9th Street which has been approved by the PA Department of Community and Economic Development. Originally the design was part of the Liberty Bell trail, taking users from S. 7th Street through the old Trolley Tunnel and down an embankment to 9th Street. The South 7th Street parcel is no

longer a viable option.

Discuss Transient Retail Business License: Food Trucks

Council discussed whether to amend the Transient Retail License for Food Trucks. Section 101-6E of the Borough Code states that a permit is required per person working on the food truck and the fee is per person. Council is recommending one permit per truck. This item can be discussed at a future meeting.

Consider Rotary Event Application: Lenape Park (Twin Bridges)

Consider Ordinance #1039, Pension Plan Update (Uniform)

Upon motion by Aigeldinger, seconded by Purcell, Council unanimously approved Ordinance #1039, an ordinance of Perkasie Borough electing to amend its pension plan administered by the Pennsylvania Municipal Retirements system pursuant to Article IV of the Pennsylvania Municipal Retirement Law agreeing to be bound by all provisions of the Pennsylvania Municipal Retirement Law as amended and as applicable to member municipalities; amending the pre-retirement death benefit from 22 years of vesting service to 20 years of vesting service, as agreed in the Collective Bargaining Agreement between the Borough of Perkasie and the Perkasie Borough Police Officers' Association.

Consider Resolution #2021-48, Upgrade to Phone System-ET&T

Upon motion by Purcell, seconded by Rose, Council unanimously approved Resolution #2021-48, a resolution of the Borough of Perkasie approving the proposal of Eastern Telephone & Telecommunications (ET&T) dated May 27, 2021, related to the purchase of the telephone equipment noted therein for the purchase price of \$45,512.62 and authorizing the Perkasie

Borough Manager to accept and execute the proposal received from ET&T on behalf of Perkasie Borough.

Emergency Federal Law Enforcement Assistance Grant Program Agreement, Authorize Signor

Upon motion by Faulkner, seconded by Rose, Council unanimously authorized the Chief of Police to sign the U.S. Department of Justice Federal Fiscal Year 2020 Emergency Federal Law Assistance Grant Program Agreement on behalf of the Borough of Perkasie.

Recommend Preliminary 2022 Budget

Upon motion by Rose, seconded by Faulkner, Council unanimously authorized the advertised of the preliminary 2022 budget for inspection by the public in accordance with Borough Code requirements, and to take all steps necessary to prepare the budget for adoption at the December 20th Borough Council meeting.
