## DOOR TO DOOR SOLICITATION AND TRANSIENT RETAIL BUSINESS APPLICATION FOR LICENSE

**Use this section if you are applying to solicit or retail door to door, or if you have a transient business that stops in one location for 30 minutes or less.**

- 1) Perkasio Borough 101-7 requires presentation of valid state or county license at time of application. EVERY INDIVIDUAL involved in solicitation or transient retail must carry a separate, individual license.
- 2) Perkasio Borough 101-8 requires carrying of this permit and to who permit if asked by police officer, Borough Officials, and residents.
- 3) Perkasio Borough 101-9 does not allow door-to-door solicitation before 9 a.m or after 7 p.m. or dusk (whichever is earlier), and does not allow for door-to-door solicitation on Sundays.
- 4) Violations can result in citations or revocation of soliciting permit. Please ask to review copy of Borough ordinances to insure you are familiar.
- 5) Perkasio Borough 124-9: No commercial services or sales of any kind permitted within the limits of the Borough park system without the expressed consent of Borough Council.

**TEMPORARY FIXED RETAIL BUSINESS  
APPLICATION FOR LICENSE**

**Use this section if you have a TEMPORARY FIXED RETAIL BUSINESS** – Any truck, trailer, sidewalk cart or temporary booth where food, beverages and/or other goods, wares or services are sold in a fixed location within the Borough on a temporary basis, **for more than 30 minutes**. Examples include food trucks, trailers and carts, as well as craft, service, non-profit, civic, or any other organization that sets up a display or stand for the purpose of selling or solicitation.

- 1) Perkasio Borough 101-13 requires presentation of valid state or county license at time of application. One individual employed by the business entity and present at the vending location must carry a permit. If a Temporary Fixed Retail Business operates in more than one location simultaneously, a permit is required for each location.
- 2) Perkasio Borough 101-15 requires carrying of this permit and to who permit if asked by police officer, Borough Officials, and residents.
- 3) Perkasio Borough 101-16 sets out regulations that must be followed by each Transient Fixed Retail Business operating with such permit. Violations can result in citations or revocation of permit. Please ask to review copy of Borough ordinances to insure you are familiar.
- 4) Perkasio Borough 124-9: No commercial services or sales of any kind permitted within the limits of the Borough park system without the expressed consent of Borough Council.

## **Door to Door, Transient Retail & Temporary Fixed Retail Vendor License Fees**

Perkasie Borough 101-6(E) Transient Retail Licenses issued under the provisions of this article shall be issued on an individual basis to persons engaging in such business; every individual shall obtain a separate license, issued to him in his name; and the license fee hereby imposed shall be applicable to every such individual license.

Perkasie Borough 101-13(D) Temporary Fixed Retail Vendor Licenses issued under the provisions of this article shall be issued to the entity operating as a Temporary Fixed Retail Business and the license fee is imposed on the business entity.
