

RESOLUTION NO. 2026-44

A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF PERKASIE APPROVING THE MEMORANDUM OF UNDERSTANDING BETWEEN CHALFONT EMERGENCY MEDICAL SERVICES, INC. d/b/a CHAL-BRIT REGIONAL EMS AND PERKASIE BOROUGH FOR THE PURPOSE OF ENHANCING THE SAFETY OF LAW ENFORCEMENT OFFICERS, DETAINED SUBJECTS, AND HOSPITAL EMERGENCY DEPARTMENT PERSONNEL BY ENABLING TRAINED CHAL-BRIT PARAMEDICS TO PERFORM CLINICAL BLOOD DRAWS IN THE CONTROLLED ENVIRONMENT OF THE PERKASIE BOROUGH POLICE STATION OR AT THE SCENE OF A DUI OR DRUG-SUSPECTED MOTOR VEHICLE ACCIDENT THEREBY SUBSTANTIALLY REDUCING THE NEED TO TRANSPORT SUBJECTS THROUGH HOSPITAL EMERGENCY DEPARTMENTS AND AUTHORIZING THE COUNCIL PRESIDENT AND/OR THE BOROUGH MANAGER TO EXECUTE THE MEMORANDUM OF UNDERSTANDING ON BEHALF OF THE BOROUGH OF PERKASIE.

WHEREAS, Chalfont Emergency Medical Services Inc. d/b/a Chal-Brit Regional EMS (“Chal-Brit”), has provided the Borough of Perkasia with a Memorandum of Understanding for the purpose of enhancing the safety of law enforcement officers, detained subjects, and hospital emergency department personnel by enabling trained Chal-Brit Paramedics to perform clinical blood draws in the controlled environment of the Perkasia Borough Police Station, or at the scene of a DUI or drug-suspected motor vehicle accident, thereby substantially reducing the need to transport subjects through hospital emergency departments.;

WHEREAS, the Borough of Perkasia, Bucks County, Pennsylvania has determined that it is in the best interest of the Borough to approve the Memorandum of Understanding; and

WHEREAS, the Borough Council herein authorizes the Council President and/or the Borough Manager to execute any and all documents related to the Memorandum of Understanding.

NOW, THEREFORE, be it resolved by the Borough Council of Perkasia Borough as follows:

1. Approval of Agreement. The Borough Council of Perkasia Borough herein approves the Memorandum of Understanding, which is attached hereto as Exhibit “A” and incorporated by reference.

2. Execution. The Borough Council further authorizes the Council President and/or the Borough Manager to execute the Memorandum of Understanding between the Borough and Chal-Brit, on behalf of Perkasio Borough.
